## Amity Integrates National Single Window System (NSWS)

The **National Single Window System (NSWS)** for sugar factories is a government of India portal required to be updated by sugar industry in India, on a regular basis. This has been made as a regulatory obligation for all sugar factories. To take care of this, Amity has designed a system duly integrated with factory's existing ERP system, including SAP. After giving an opportunity to verify and re-confirm the data, it pushes the required data to NSWS site and automatically generates Proforma-II. If a factory does not have proper ERP system, they can upload data using excel templates or even through manual data entry.

The system has already been successfully integrated for more than 25 sugar factories.

## Amity Software Implements Proprietary EWS System for Kenya Tea Development Agency

Amity Software has successfully implemented its advanced Electronic Weighing System (EWS) across 41 factories of the Kenya Tea Development Agency (KTDA), which represents 630,000 tea farmers. Established in 1964, KTDA manages 69 factories and produces over 326 million kilograms of tea annually.



As part of the project, Amity provided over 400,000 smart cards to farmers, enabling seamless tracking of transactions and integration with electronic weighbridges. The EWS system supports mobile payments and a wide range of farm-level activities, including farmer registration, fertilizer distribution, farm checks, and data collection. With RFID-based product traceability and SMS/USSD communication for farmers, the system enhances efficiency and transparency.

Amity initiated this by proposing this project to KTDA, who saw its potential value in driving in efficiency, productivity and transparency in operations. After piloting with multiple vendors, KTDA selected two vendors. Amity won the majority share of the business due to the superior quality of its software and services.

## Berhan Insurance Nears Final Stages of **AmityAssure** Implementation
